- Dates for the Junior Naturalist Camp are: June 3rdth-7th for students age 8 12. Cost is \$100 a camper/week.
- Hours are 9:00 am to 3:00 p.m. Parents are asked to please drop off and pick up their child on time.
- Strawberry Plains Audubon Center is located at 285 Plains Road, Holly Springs, MS. We are located off Highway 311, just north of Holly Springs. Please call for directions before the first day of camp or use the links on our <u>website</u> for directions.
- Campers will be outdoors most of the day. Please dress for the weather. Lightweight, long pants are recommended. Light colored clothing will be cooler than dark colors. A hat is recommended.
- Closed-toed shoes are a must! No sandals or flip-flops are allowed.
- Sun block and bug repellant should be applied before campers are dropped off. Please send campers with additional product to reapply throughout the day.
- Please send you child to camp with a sack lunch each day. We have refrigeration available, but please do not send any lunch items that must be cooked or microwaved. Audubon will provide a mid-morning snack.
- Registration fees are due with your registration form and liability waiver. Registration deadline is May 29th, 2020.
- Register early, as space is limited. Spaces will be filled on a first-come, first-serve basis based on the postmark date.
